Terms and Conditions

The undersigned certifies and warrants that:

1. He/she is authorized on behalf to the Corporation/Partnership to make this application and has authority to bind the Corporation/Partnership.
2. That the information disclosed herein is true and accurate, and affirms that any credit given is to be extended upon the basis of such information.
3. Acknowledges that it is the sole responsibility of the Applicant to forthwith advise us of any changes in the above information throughout the ongoing course of our commercial relationship.
4. That the Applicant consents to the release of such ongoing financial information as the Creditor deems necessary to extend and/or maintain credit with the Applicant and that this executed application (or any true copy thereof) shall be good and sufficient authority to the said sources for the release of such information.
5. Further, the Applicant consents to the obtaining of such credit and/or personal information as the Creditor deems necessary at any time in connection with the credit hereby applied for, or any renewal or extension thereof, and to the disclosure of any credit information to the Creditor concerning the Applicant to any credit reporting agency or to any person with whom the Applicant has, or proposes to have financial relations.
6. The Creditor shall have the right to offset any payable due to the Applicant should the account go beyond normal credit terms.
7. The applicant agrees further to accept the terms of the Creditor (payment in full - Net 30 days) and agrees to pay interest charges of 26.82% per annum (2% per month) compounded monthly on any overdue balances until paid.
8. Any complaints regarding failure to deliver, or insufficient quantity or quality of goods must be made in writing within 30 days of the date of the invoice, failing such the customer is deemed to have accepted the invoice as an accurate statement of goods delivered and amounts owing and to have waived any claim as to failure to deliver or quality or quantity of goods and services indicated on the invoice.
9. The applicant agrees that it may take 7 days to process this application, and agrees to pay C.O.D. terms until credit is approved.
10. Returned cheques will be subject to a \$30 service charge.
11. Cash discounts will be offered from time to time and communicated on the sales invoice. A cash discount taken accompanied by payment after the due date will not be allowed and interest stated as above, charged on the past due amount.
12. Any returned items will be subject to a restocking charge of 15% with a minimum of \$15.00.
13. In the event of default by the customer on any term or terms of this agreement, any and all costs incurred by the Creditor for the enforcement of the agreement or for the recovery of any monies owed under the agreement shall be considered as part of the principal debt owing and such sums shall include but not be restricted to costs of any collector or collection agency.
